Residential – Marrick Priory

Dear Parents/Carers,

Next year when your child is in Year 5, there will be the opportunity to attend a residential trip. The residential for next year's Year 5 class will take place from Monday 9th March 2026 to Friday 13th March 2026. The cost of the visit will be £385.00 per child. This price includes all travel to and from the venue in Swaledale - North Yorkshire, 4 nights accommodation, all meals, snacks and drinks for the full week, all activities and trained staff at the site, and all travel to each individual activity.

There will be a parent's information meeting on 11^{th} September 2025 at 3.20pm. If you would like to wait until then to decide if your child is attending, the payments below will be available on MCAS from September.

Parents can pay the full balance if this is preferable by adding each payment item to the basket and paying the full amount, adding a few to make up an affordable amount or paid in instalments as outlined below. All instalment amounts, however, must be paid on or before the deadlines set out below.

£50.00 – Marrick 2026 Deposit – 15th September 2025 £67.00 – Marrick 2026 Payment 1 due 15th October 2025 £67.00 – Marrick 2026 Payment 2 due 17th November 2025 £67.00 – Marrick 2026 Payment 3 due 15th December 2025 £67.00 – Marrick 2026 Payment 3 due 16th January 2026 £67.00 – Marrick 2026 Payment 3 due 15th February 2026

If you would like to get a head start on payments you can pay the following instalments this academic year up to 18th July 2025 - Marrick 2026 A, Marrick 2026 B, Marrick 2026 C, and Marrick 2026 D. All payments can be found in the 'Store' on MCAS.

You would then pay: £50.00 - Marrick 2026 Deposit paid by 15th September 2025 And 3 x £67.00 - Marrick 2026 Payments by 15th February 2026

Tax-Free Childcare Vouchers

If you are eligible, you can also pay with the government's Tax Free Childcare vouchers for the amount of time spent outside of school hours. For this residential trip the split is 29% school hours and 71% out of school hours. Parents can therefore use tax-free childcare vouchers to pay £273.35 and pay the remainder of £111.65 by card on MCAS. If you would like to pay by childcare vouchers please simply send the vouchers to us and we will add the payment for £111.65 to your MCAS account.

Please encourage your child to attend the residential visit as this is a fantastic opportunity for the children to participate in a variety of different activities in the rural and beautiful venue in the heart of the Yorkshire Dales National Park. If your child will not be attending the residential, please inform the office as soon as possible.
